6. Artificial Intelligence in Finance

BITA's AI stack is built using a combination of:

- **Machine Learning (ML)** for market analysis and scoring
- **Natural Language Processing (NLP)** for chatbots and advice tools
- **Reinforcement Learning** for improving investment strategies
- **Predictive Models** for market movements and credit risk

We're building a real-time, AI-enhanced engine to assist users in navigating DeFi with confidence.

7. Technical Architecture

- **Blockchain Layer:** Binance Smart Chain (BEP-20 standard)
 - **Smart Contracts:** Written in Solidity, audited, with upgradability via proxy
 - **AI Layer:** Python-based backend, TensorFlow and PyTorch models
 - **Frontend:** Web3 dashboard (React), WalletConnect integration
 - **Security:** Multi-sig governance wallet, time-locks, contract audit
 - **APIs:** Open APIs for developers to plug into BITA's AI tools
